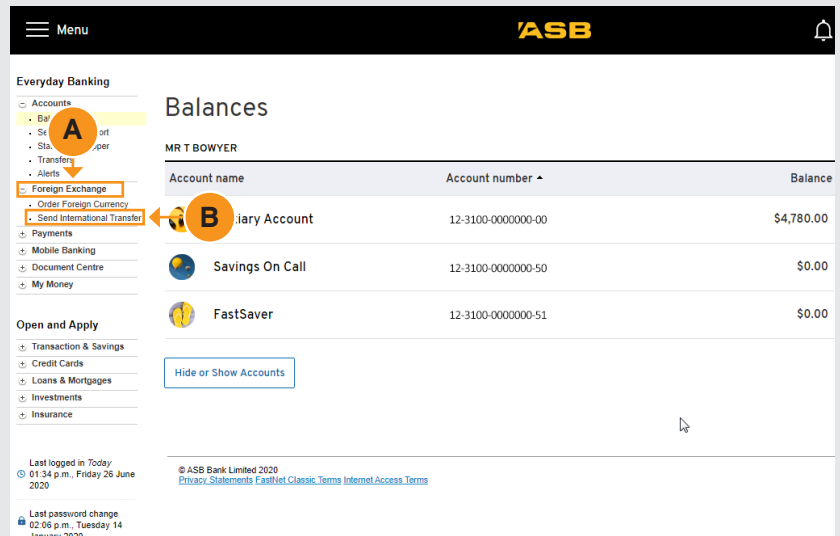


# How to make an International Money Transfer using FastNet Classic internet banking

## STEP 1:

Go to **Foreign Exchange** **A** and select **Send International Transfer** **B**.

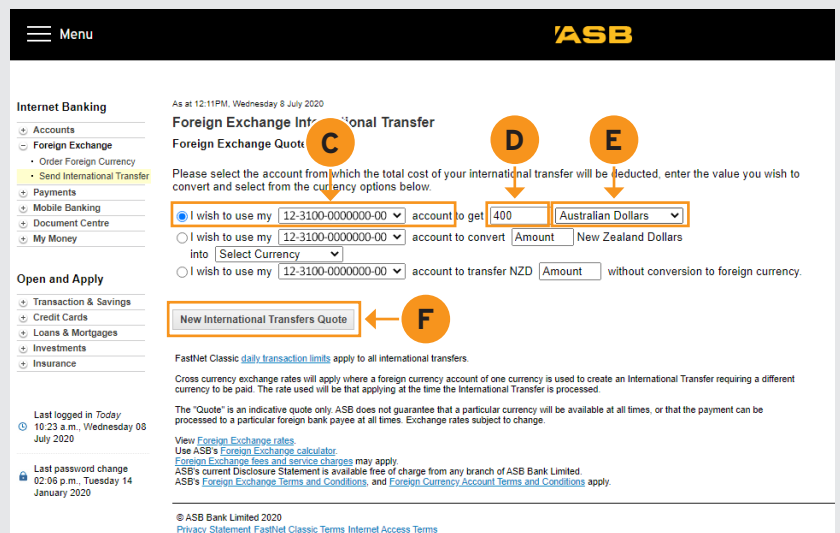


## STEP 2:

Select one of the three **conversion options**.

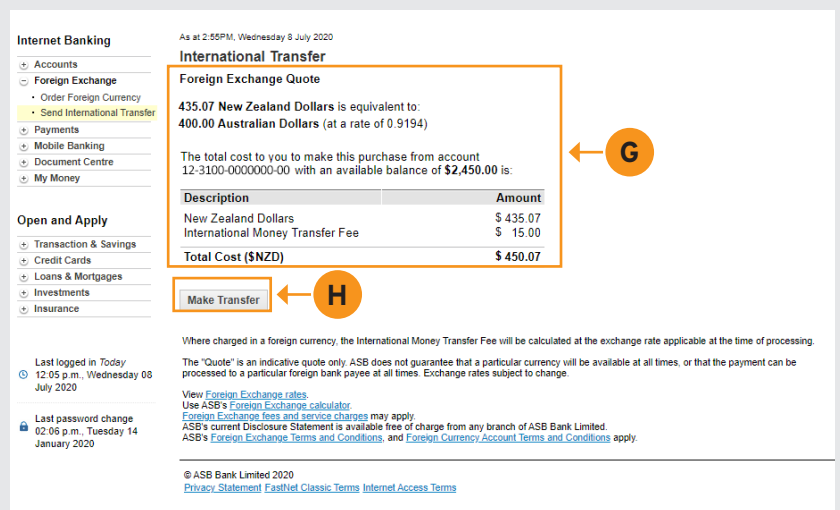
Select the **account** **C** which the total cost of the International Money Transfer (IMT) will be deducted from; enter the **amount** **D** you wish to convert and select the **currency** **E** you wish to convert to.

Then select **New International Transfer Quote** **F**.



## STEP 3:

Review the Foreign Exchange Quote **G** and select **Make Transfer** **H** to proceed.



## STEP 4:

To complete your IMT you must:

**I** Be registered for **Netcode** and have your **Netcode registered mobile phone** with you.

**J** Have all the **Transfer Details**.

Select **Next** **K** to continue.

## STEP 5:

Enter your **Beneficiary's Bank Details**. If you have the SWIFT code of the beneficiary's bank, enter the **SWIFT code** **L**.

If not, search for the details by entering the country and city of the beneficiary bank **M**.

Then select **Next** **N**.

## STEP 6:

Enter the **Beneficiary Account Holder Details** **O** and enter the **details to appear on the beneficiary's statement** if needed **P**. Select who will pay for the **Other banks' charges** **Q**.

## STEP 7:

Enter the **details to appear on your statement** **R** and select **Next** **S** to continue.

## STEP 8:

Check the details of your international transfer are correct **T** and select **Submit** **U** to continue.
