### What is the purpose of this update?

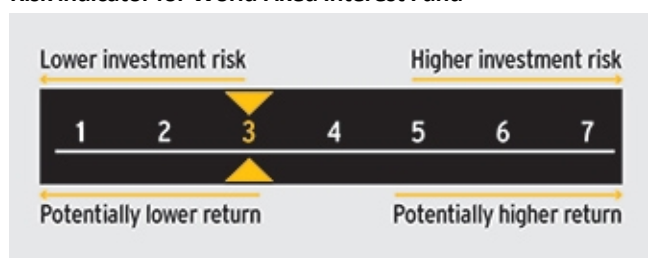
### Description of this fund

To provide exposure to a portfolio of investment grade international fixed interest investments, with a negative return expected less than one in every 25 years. The World Fixed Interest Fund invests in a target investment mix of 100% income assets.

### What are the risks of investing?

#### Risk indicator for World Fixed Interest Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

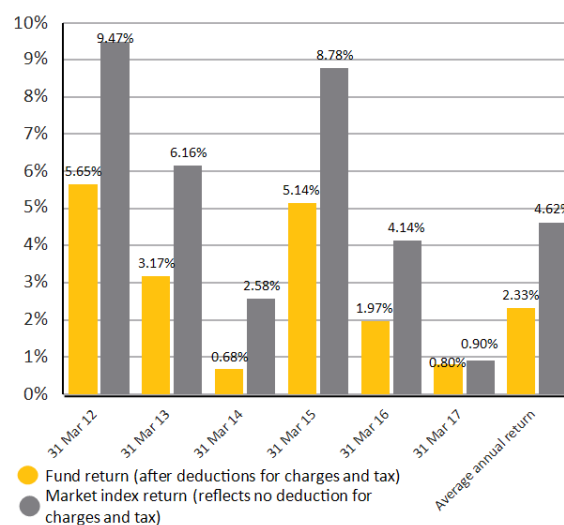

### Annual return graph



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 December 2017.

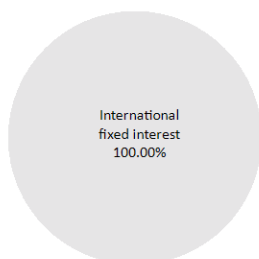
### Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason received a return after fund charges were deducted of \$125.00 (that is 1.25% of his initial \$10,000). Jason also paid \$0.00 in other charges. This gives Jason a total return after tax of \$125.00 for the year.
