What is the purpose of this update?

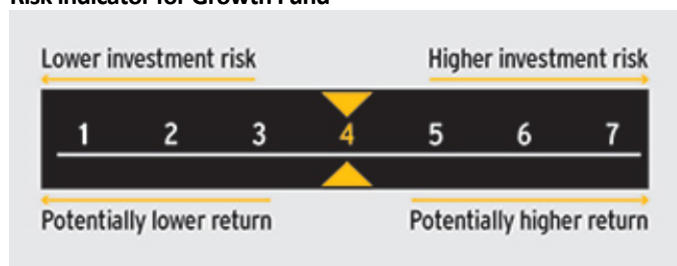
Description of this fund

To provide high total returns allowing for large movements of value up and down. The number of years with negative returns are generally expected to be the highest of the multi-sector funds in the ASB Investment Funds. We manage asset allocation and currency hedging over the medium to long term relative to the target investment mix. We focus on cost effective management. The Growth Fund invests in income and growth assets with a target investment mix of 20% income assets and 80% growth assets.

What are the risks of investing?

Risk indicator for Growth Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

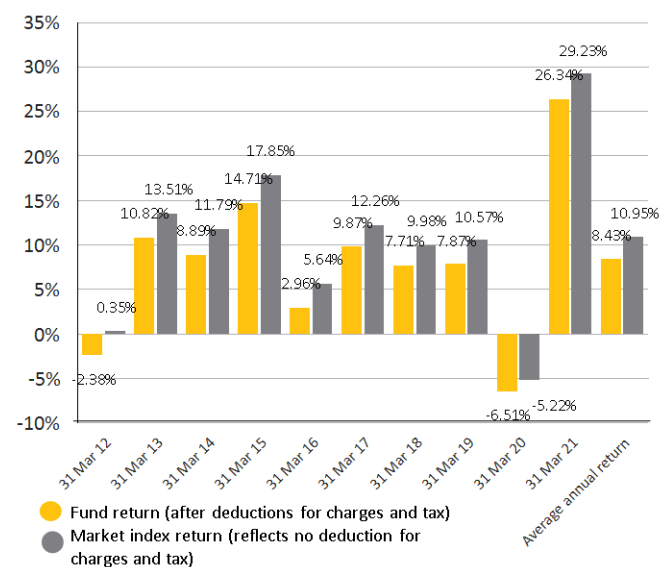

How has the fund performed?

Annual return graph



This shows the return after fund charges and tax for each of the last 10 years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 30 June 2021.

Small differences in fees and charges can have a big impact on your investment over the long term.

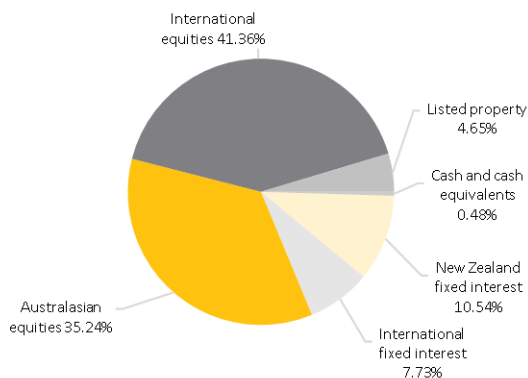
Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason received a return after fund charges were deducted of \$1,773.00 (that is 17.73% of his initial \$10,000). Jason also paid \$0.00 in other charges. This gives Jason a total return after tax of \$1,773.00 for the year.

Actual investment mix

This shows the types of assets that the fund invests in.



Currency hedging

As at 30 June 2021 the fund's exposure to assets denominated in foreign currencies was 66%, of which 64% was hedged. This means the fund's unhedged foreign currency exposure was 24% of the net asset value of the fund.
